1. Why is there a need to transfer funds? (Example: Economic conditions such as high/low unemployment, business closures, etc.) In the past two years, LWDB 51 has had to deal with several natural disasters, which in turn caused low foot traffic in the American Job Centers. Our area was resilient and most of the community that left are coming back. Our foot traffic has increased, as well as our enrollments. Most of our WIOA dollars are spent in the adult funding stream on training and support services, hence the need to transfer dollars from DW to Adult. Historically, LWDA 51 has served more Adults with ITA's as opposed to Dislocated Workers, as our Dislocated Worker population tend not to want to engage in any type of long term training.
2. How will the transfer of funds affect the participant levels in both the Adult and Dislocated Worker Programs? Provide an estimated number of Adult and Dislocated Workers expected to be served if the transfer is granted. The transfer will increase the number of adults who can be served. There will not be a decrease in the number of dislocated workers served. LWDB 51 projects to serve about 100 adults, and 20 dislocated workers.
3. Explain the impact on jointly funded employment and training programs in the Local Service Delivery System. Currently there are no jointly funded employment training programs in the Local Service Delivery System.
