It also provides career counseling, training, and job placement services to ex-offenders, to help them secure meaningful and gainful employment that pays a decent wage. This component is intended to help curtail the revolving door of recidivism.

The Business Services Specialist (BSS) scheduled **Thirteen** workshops for the month April - June 2024. There were **22 attendants** for J-Core/Re-Entry Program

What prompted the participant to visit the American Job Center office?

Justin Davison is a 31 man who has a fiancé and a baby boy who is just a few months old. He spent some time in jail and after being released, Justin decided to make changes in his life. He knew he not only needed a job, but he needed a career, and truck driving was something he was interested in. Justin heard about WIOA assistance through a friend. He came to the American Job Center in hopes of receiving financial assistance for truck driving school. Justin felt obtaining a Class A CDL would open up many opportunities for him to have a career.

What services were received by the participant? (Include all relevant WIOA services.)

Justin's services through the Workforce Innovation and Opportunity Acts Program began with completing a Wagner-Peyser and discussing the Workforce Innovation and Opportunity Program. Justin received an eligibility packet that needed to be completed and returned in order to move forward with the eligibility process. Justin's eligibility was processed, and he was deemed eligible for WIOA funding based on him living in a household with someone who receives SNAP benefits. His HiRE Core application, Objective Assessment, and an Individual Employment plan was successfully completed. At this time, it was determined that the WIOA Adult Program would assist Justin with funding for tuition him to attend Coastal Truck Driving School and obtain his Class A CDL. The training prepares the student for entry-level employment int the trucking industry. Justin completed the 160-hour course curriculum which consists of classroom and practical instruction using current model equipment. A Career Counseling Activity Code and a new Individual Employment Plan was created in HiRE to assist client in finding full time and permanent employment. Justin graduated on June 25, 2024. During his training, he was hired by Deep South Productions to load and unload equipment on and off the trucks. After graduation, Deep South Productions offered Justin full time employment as a CDL truck driver, hauling their equipment to different venues across the South.

In what ways did the services help the participant achieve success? (Please be specific.)

The Workforce Innovation and Opportunity Act Program helped Justion achieve success by funding his tuition. Justin had been working hard for a couple of years to make better decisions and to stay on a positive path. The services were available to him at the right time in his life to keep him positive and to show him that he could be the man, dad, and future husband he wanted to be.

How does the participant feel he or she benefited by visiting the American Job Center?

Justin feels grateful his friend told him about the WIOA program. If he had not heard about it, he would probably still be working in fast food or housekeeping. Because he visited the American Job Center, he now has a career with a growing, successful company.

Additional Comments:

Justin is an incredible young man whose life was on the wrong path and has made a decision to make positive changes in his life. He set a goal and was very determined to reach that goal, even with many hurdles in his way. He is a perfect example of how WIOA can literally change someone's life just by giving them a helping hand.
