to the secondary property owners on the south side of the Gulf Intracoastal Waterway in cases where alternative access is lost, and 4) serve as an amicable solution to the road abandonment request that had opposing interests. On October 6, 2011, the Police Jury deferred this item until November 3, 2011. On November 3, 2011, the Police Jury deferred this item until November 17, 2011.

12. **Take appropriate action** on RZ04-010-11, which is a request by Great Southern Group, LLC, and Glen and Darleen James to rezone from C-1 (Light Commercial) to I-1 (Light Industrial) to allow light industrial development (office/warehouse) on Mosswood Drive in Ward Four. (District 15, Mr. Farnum)

[The Planning and Zoning Board met on Tuesday, November 15, 2011, and voted unanimously that the request be granted with the following stipulations: 1) that the development adhere to the site plan on file with the Division of Planning and Development, provided that the Director of Planning and Development or designee may authorize adjustments to site plans in light of technical or engineering considerations discovered during development; 2) that a Developer's Agreement must be signed with the Division of Planning and Development prior to certificate of occupancy; 3) that the development adhere to storm water best management practices; and 4) that sewer must be approved by the Department of Health and Hospitals (DHH).]

- 13. Consideration of adopting resolutions indicating objection/no objection to the following proposed projects in Calcasieu Parish, Louisiana, provided said work meets with the rules and regulations of the Corps of Engineers, Best Management Practices during the course of construction set forth by the Environmental Protection Agency guidelines, and approvals are received from all other appropriate state and federal agencies, and further that any required permits are obtained from the Division of Planning and Development:
 - (13.1) Proposal of Robert and Mandy LaFleur to clear a 7.0 acre site, redistribute 5,700 cubic yards of graded earthen material, and place 750 cubic yards of hauled-in earthen material, along with 250 cubic yards of concrete, all to construct two home sites and two barns. Said project is located in the Carlyss area of Sulphur, Louisiana. *The Planning Staff recommends that the Police Jury indicate no objection to this project application*.
 - (13.2) Proposal of Sheron Faulk to construct a private dock area for the property owner's personal boats, including but not limited to a 27' x 14' catamaran sailboat and 3-4 fishing boats. Said project is located off Intracoastal Park Road in Sulphur, Louisiana. *The Planning Staff recommends that the Police Jury indicate no objection to this project application*.

AGENDA NOTE: Any resolution of no objection to any project, if adopted, will stipulate that such "no objection" is based solely on evaluation by the Parish Planning and Development Staff relative to the project's compliance with current parish ordinances and provisions, and that no environmental assessment was made, and further, requesting the agencies and/or

individuals with environmental expertise to make an evaluation and forward their findings to the U.S. Corps of Engineers.

- 14. Consideration of adopting a resolution approving a Coastal Use Permit application for Cecos International, Inc., (c/o Oliver Ford, Jr.) for plugging and abandonment of the existing monitoring well MW-1C and drilling a replacement well within ten-to-fifteen feet of the existing well as part of ongoing site assessment activities occurring at the Ellender Ferry Facility under the approval of the LDEQ Remediation Services Division. Said project is located on Old Highway 27, south of the Intracoastal Waterway. (District 12, Mr. Clement)
- 15.
