  - (13.1) Proposal of Brian Lee Michel to place approximately 1,200 cubic yards of earthen material to prepare site conditions needed to support construction of home site, garage and yard. Said project is located in the 900 block of River Road in Lake Charles, Calcasieu Parish. *The Planning Staff recommends that the Police Jury indicate no objection to this project application.*
  - (13.2) Proposal of Dr. Jagjit Chadha, c/o Curtis Vincent, Vincent-Shows Architects, to install and maintain 183-linear feet of bulkhead and place approximately 617 cubic yards of hauled-in earthen material as fill behind the bulkhead, all to reclaim property lost due to erosion. Said project is located at 904 Shell Beach Drive in Lake Charles, Calcasieu Parish. *The Planning Staff recommends that the Police Jury indicate no objection to this project application.*
  - (13.3) Proposal of J and J Diving Corp to hydraulically dredge to remove 978 cubic yards of accumulated sediment under the hull of the Isle of Capri

Grand Palais Vessel and return sediment to scoured out areas created by the vessel's bow thrusters. Said project is located at 100 Westlake Avenue in Westlake, Calcasieu Parish. *The Planning Staff recommends that the Police Jury indicate no objection to this project application.* 

- (13.4) Proposal of CM Charter Capital, LLC, Attn: Andy Curley, to conduct operations to include clearing and grading of approximately 20 acres to construct a Commercial Business Development Project consisting of retail stores, Frontier Hospital and parking areas. Approximately 30,000 cubic yards of native earthen fill and 11,000 cubic yards of aggregate materials will be placed in areas for proposed building foundations and parking lots. Said project is located adjacent to 5<sup>th</sup> Avenue in Lake Charles, Calcasieu Parish. *The Planning Staff recommends that the Police Jury indicate no objection to this project application*.
- (13.5) Proposal of Delta Land Services to deposit approximately 6,009 cubic yards of earthen material to fill 5,905 linear feet of drainage ditches and 2,820 feet of channelized, natural drainage for the purpose of establishing a mitigation bank. Said project is located 5.5 miles southwest of Sulphur on John Brannon Road, Calcasieu Parish. *The Planning Staff recommends that the Police Jury indicate no objection to this project application.*
- AGENDA NOTE: Any resolution of no objection to any project, if adopted, will stipulate that such "no objection" is based solely on evaluation by the Parish Planning and Development Staff relative to the project's compliance with current parish ordinances and provisions, and that no environmental assessment was made, and further, requesting the agencies and/or individuals with environmental expertise to make an evaluation and forward their findings to the U.S. Corps of Engineers.
