- 8. Consideration of approving the minutes of the Regular Meeting of the Police Jury dated October 3, 2013.
- 9. Consideration of approving the Ways and Means Committee Report dated October 24, 2013. Said Committee:
  - (9.1) Recommended that resolutions be adopted calling a special election to be held in Calcasieu Parish, Louisiana, on Saturday, April 5, 2014, for authority of the Calcasieu Parish Police Jury to:
    - (9.1.1) Renew, levy and collect an existing two and forty-one one-hundredths (2.41) mills special tax on all properties subject to taxation within the boundaries of the Parish, for a period of ten (10) years, beginning January 1, 2015, and ending December 31, 2024, with collections from the renewed levy estimated to be \$4,157,088 for one entire year, for the purpose of maintaining and operating the facilities and services of the Calcasieu Parish Mosquito Control Program, as well as improving or constructing mosquito control facilities;

- (9.1.2) Renew, levy and collect an existing three and sixteen one-hundredths (3.16) mills special tax on all properties subject to taxation within the boundaries of the Parish, for a period of ten (10) years, beginning January 1, 2015, and ending December 31, 2024, with collections from the renewed levy estimated to be \$5,450,788 for one entire year, for the purpose of operating, maintaining, and improving the facilities and services of the District Attorney and District Court of the 14<sup>th</sup> Judicial District in Calcasieu Parish, Louisiana (The Honorable David Ritchie, Chief Judge of the 14<sup>th</sup> Judicial District Court, and The Honorable John DeRosier, Calcasieu Parish District Attorney, appeared before the Committee in support of the renewal of this tax.);
- (9.1.3) Renew, levy and collect an existing sixty-three one hundredths (.63) mill special tax on all properties subject to taxation within the boundaries of Airport District No. One, for a period of ten (10) years, beginning January 1, 2015, and ending December 31, 2024, with collections from the renewed levy estimated to be \$688,940 for one entire year, for the purpose of operating, maintaining, and improving the facilities of Lake Charles Regional Airport (Mr. Heath Allen, Executive Director of the Airport, appeared before the Committee in support of the renewal of this tax); and
- (9.1.4) (as the governing authority of Waterworks District No. Five of Wards Three and Eight a.k.a. Mallard Junction) to renew, levy and collect an existing six and thirty-nine one-hundredths (6.39) mills special tax on all properties subject to taxation within the boundaries of the District, for a period of ten (10) years, beginning January 1, 2015, and ending December 31, 2024, with collections from the renewed levy estimated to be \$160,079 for one entire year, for the purpose of acquiring, constructing, improving, maintaining or operating waterworks facilities within said District.
- (9.2) Recommended approval of the following items related to the proposed sewerage expansion plan approved by the Police Jury on October 3, 2013:
  - (9.2.1) Authorize advertisement of a public hearing to be held on November 7, 2013, at 6:00 p.m. to receive input on the creation of a parishwide sales tax district, excluding municipalities, to be known as Sales Tax District No. Five of Calcasieu Parish, and following the public hearing, to consider adoption of an ordinance creating said district and adoption of a resolution authorizing publication of the geographical limits of the district; and
  - (9.2.2) Adopt a resolution calling a special election within Sales Tax District No. Five for the purpose of submitting to the electorate the question of the imposition of a sales and use tax in the amount of one-fourth percent (1/4%) to be levied parishwide in the unincorporated area, excluding municipalities, for a period of 20 years, beginning January 1, 2015, with collections estimated to be \$4,300,000 for one entire year, for constructing, improving and maintaining sewers and sewerage works and acquiring the necessary equipment and furnishings therefor; to issue bonds to be retired with, paid from and secured by an irrevocable pledge and dedication of the tax, and further, providing a covenant with the voters that in the event the tax is approved within Sales Tax District No. Five, the current road and garbage sales tax levied by the Police Jury within Sales Tax District No. 4-A will be reduced by one-fourth percent (1/4%) for the remaining authorization period of said tax.

- Mr. Charlie Atherton, 122 Vine Street, Sulphur, appeared before the Committee with reference to this election call, expressing concern that the municipalities had not yet entered into cooperative endeavor agreements to participate in the proposed sewerage expansion plan, as well as concern that the ad valorem tax for road improvements would be increased if there was a shortfall in funding as a result of diminution of the sales tax levied in Sales Tax District No. 4-A (should the sewer tax pass).
- <u>AGENDA NOTE</u>: The 1.5% road and garbage sales tax is levied in Sales Tax District No. 4-A, which consists of unincorporated areas in Wards 2 through 8. The tax is <u>not</u> levied in Ward 1 (Moss Bluff/Gillis), and therefore the reduction would not apply to Ward 1.
- 10. <u>Hold a public hearing at 6:00 p.m.</u>, to receive input on the creation of a parishwide sales tax district, excluding municipalities, to be known as Sales Tax District No. Five of Calcasieu Parish, and following the public hearing, to consider adopting an ordinance creating said district and a resolution authorizing publication of the geographical limits of the district.
- 11. Consideration of approving the Budget Committee Report dated October 24, 2013. Said Committee:
  - (11.1) Recommended that various requests from special service districts/public entities for grant funding from the Gaming Fund be approved. Each item, if approved, will include adoption of a resolution approving a Cooperative Endeavor Agreement between the Police Jury and the requesting entity, as well as authorization for the President of the Police Jury, or his designee, when appropriate, to execute all documents related thereto. The requests are as follows:
    - (11.1.1) <u>Ward One</u> Ward One Fire Protection District No. One \$10,700 for costs associated with the purchase of a fire hose and miscellaneous equipment for a new fire truck;
    - (11.1.2) <u>Ward Two</u> Community Center and Playground District No. Seven of Ward Two \$200,000 for the purchase and installation of lights at the Miller Alexander Sports Complex facility;
    - (11.1.3) Ward Three City of Lake Charles an amount up to one-quarter of the total cost, not to exceed \$95,000 (\$47,500 from Ward Three Allocation and \$47,500 from Economic Development Allocation) for Tank Farm Road Water and Sewerage Expansion; (With reference to this item, Mr. Landry noted for the record that if property owners are assessed on a front-foot-assessment basis in the future for the cost of these improvements, as much of this grant funding as possible should be returned to the Parish gaming fund.)
    - (11.1.4) <u>Ward Four</u> Ward Four Fire Protection District No. Two \$15,000 from District 12 for costs associated with the purchase of a generator for Fire Station No. Four;
    - (11.1.5) <u>Ward Four</u> Town of Vinton \$1,500 from District 13 for costs associated with the marketing and promotion of the Vinton Heritage Festival which was held on October 12, 2013;

- (11.1.6) <u>Ward Four</u> Human Services Department \$6,500 from District 13 for the Sulphur Housing Christmas Giving Program;
- (11.1.7) <u>Ward Four</u> Waterworks District No. Two of Ward Four \$15,850 from District 14 for costs associated with the repair of the east water well on Water Tower Road in Mossville;
- (11.1.8) <u>Ward Four</u> City of Sulphur \$16,660 from District 15 for drainage improvements at the intersection of Eveland Street and East End Avenue; and
- (11.1.9) <u>Ward Seven</u> Ward Seven Fire Protection District No. Two \$8,000 for costs associated with the purchase of computers and various emergency response equipment for the District.
- (11.2) Recommended that a resolution be adopted approving an extension of the Cooperative Endeavor Agreement between the Police Jury and Ward Four Fire Protection District No. Four which provided a grant in the amount of \$50,000 for costs associated with parking and driveway improvements at the fire station located at 789 West Houston River Road in Sulphur.
- <u>AGENDA NOTE:</u> This grant was approved on October 18, 2012, and the District is requesting an extension in order to complete the project.
- 12. Consideration of approving the Public Works Committee Report dated October 24, 2013. Said Committee:
  - Received report from Mrs. Pam Mattingly of the Planning and Development Staff regarding the proposed revision of the Zoning and Development Ordinance relative to Floodplain Management which would require a one-foot freeboard ("freeboard" defined as an additional amount of height above the base flood elevation used as a factor of safety in determining the level at which a structure's lowest floor must be elevated or floodproofed to be in accordance with state or community floodplain management regulations) for all new construction and substantial renovations in the Parish in order to reduce individual property owners' flood insurance costs and to increase the Community Rating System (CRS) discount from a Class 8 (10% discount) to a Class 7 (15% discount). A public comment period on the proposed revisions will run through November 19th with Police Jury action scheduled for November 21<sup>st</sup>. The proposed revisions and opportunity to submit comments thereon will be available on the website at www.cppj.net beginning October 25th. Mr. Hunter recommended that these revisions be widely publicized prior to adoption, and Mr. Spell recommended that provisions be included in the revisions to prevent run off from built-up properties onto existing and adjacent properties that are lower in elevation. Mr. Charlie Atherton, 122 Vine Street, Sulphur, appeared before the Committee and asked that the Police Jury do everything it could to fully staff, fund and publicize the Parish's CRS program.
  - (12.2) Recommended that a resolution be adopted renaming a portion of Highway 3059 (from the intersection with River Road, south to the intersection with Pujol Road) to *Pujol Road*. (District 2, Mr. Mayo, and District 10, Mr. Stelly)
