- 7. Take appropriate action on applications for liquor and beer permits. (Mr. Vickers)
- 8. Consideration of approval of the minutes of the Regular Meeting of the Police Jury dated March 18, 2009.
- 9. Take appropriate action on RA03-001-09 which is a request by the Lake Charles Harbor and Terminal District to abandon 3,000 feet more or less of Joe LeDoux Road. (Joe LeDoux Road in Ward Three, Police Jury District 8, Mr. Brame)
  - [No action necessary. The Planning and Zoning Board met on Tuesday, April 21, 2009, and deferred action for thirty days.]
- 10. Take appropriate action on RA03-003-09 which is a request by the Lake Charles Harbor and Terminal District to abandon a 50' x 350' right-of-way off of Big Lake Road in Ward Three. (off of Big Lake Road in Ward Three, Police Jury District 8, Mr. Brame)
  - [The Planning and Zoning Board met on Tuesday, April 21, 2009, and voted unanimously to recommend that the request be granted.]
- 11. Take appropriate action on RZ03-007-09 which is a request by Momentum Resources to amend Ordinance No. 5212 and to revert property from R-1 (Single Family Residential) to I-2 (Heavy Industrial) to allow heavy industrial development. (West Tank Farm Road in Ward Three, Police Jury District 8, Mr. Brame)
  - [The Planning and Zoning Board met on Tuesday, April 21, 2009, and voted 8 (for) and 3 (against) to recommend that the request be granted.]
  - <u>AGENDA NOTE</u>: in December, 2006, the Planning and Zoning Board and the Police Jury granted a request by the petitioners to rezone from I-2 (Heavy Industrial) to R-1 (Single Family Residential) to allow a residential subdivision. The petitioners would now like to revert a portion of the property to I-2 (Heavy Industrial) for heavy industrial development.
- 12. Consideration of adopting a resolution to amend the Fee Schedule utilized by the Division of Planning and Development, as adopted on December 7, 2006, and amended on September 6, 2007, to include the fees for appraisal of adjudicated property as follows:

<u>AGENDA NOTE</u>: Act 819 of 2008 adopted by the Louisiana State Legislature requires a licensed appraiser to appraise the value of the adjudicated property, which eliminates broker's opinions.

- 13. Consideration of adopting an ordinance amending Ordinance No. 5638 which was adopted on March 18, 2009, relative to Zoning Case RZ08-005-09, to correct a typographical error in the zoning case number.
- 14. Receive report from Allen Smith, General Counsel to the Police Jury, on the condemnation status of eleven manufactured homes located at 1331 Alton Pierce Road in Ward Six.
- 15. Receive report from staff regarding the Community Development Block Grant Disaster Recovery Program and consideration of adopting a resolution approving a Cooperative Endeavor Agreement between the Police Jury and the State of Louisiana, Division of Administration, Office of Community Development, Disaster Recovery Unit, to implement grant funds under said program, in response to the damages caused by Hurricanes Gustav and Ike in 2008, and further, authorizing the President of the Police Jury, or his designee, when appropriate, to execute all documents related thereto.

<u>AGENDA NOTE</u>: the total allocation for Calcasieu Parish is estimated to be \$17,707,489.00.

16. Consideration of adopting a resolution supporting an application in the amount of \$100,000 by Waterworks District No. One of Ward One to the Louisiana Office of Community Development, Community Water Enrichment Fund, for a waterline overlay project on Cascio and Thompson Roads in said Waterworks District in Ward One, and ratifying the signature of the President of the Police Jury on this application submittal, and further, authorizing the President of the Police Jury, or his designee, when appropriate, to execute all documents related thereto.

<u>AGENDA NOTE</u>: the Waterworks District received notification at the beginning of last week that funding was available for this purpose, and a draft of this proposed resolution was given to the Waterworks District on Thursday, April 9, 2009, to attach to their application since the application was due by Friday, April 10, 2009.

17. Consideration of adopting an ordinance establishing the franchise fee to be paid by entities providing cable or video service within the unincorporated areas of Calcasieu Parish under a state-granted franchise authority at a rate of five-percent (5%) of the cable or video service provider's gross revenues, as that term is defined by the "Consumer Choice for Television Act of 2008," derived from operations within the unincorporated areas of the parish, and further, authorizing the President of the Police Jury, or his designee, when appropriate, to execute all documents related thereto.

<u>AGENDA NOTE</u>: this proposed action will not result in any franchise fee increases now, or in the future, to any cable customers within the unincorporated areas of Calcasieu Parish.

- 18. Consideration of adopting a resolution approving the issuance, sale, and delivery of not exceeding \$850,000 of Bond Anticipation Notes of Waterworks District No. Eight of Wards Three and Eight for the purpose of acquiring extensions and improvements to the waterworks system, at the request of the Board of Commissioners of said Waterworks District.
- 19.   - (20.1) adopt a resolution authorizing the Office of Juvenile Justice Services to submit a continuation application/certifications in an amount up to \$200,000, and any revisions thereafter, to the Louisiana Supreme Court which outlines the certifications and budget of the Calcasieu Parish Juvenile Drug Court Treatment Program, and should residual funds become available, a grant adjustment can be filed to increase the grant award, and further, authorizing the President of the Police Jury, and/or his designee, when appropriate, to execute all documents related thereto.
  - (20.2) adopt a resolution authorizing the Office of Juvenile Justice Services to submit an application in an amount up to \$300,000, and any revisions thereafter, to the Louisiana Commission on Law Enforcement for enhancement of the Calcasieu Juvenile Drug Court Treatment Program, and should residual funds become available, a grant adjustment can be filed to increase the grant award, and ratifying the signature of the President of the Police Jury on this application submittal, and further, authorizing the President of the Police Jury, and/or his designee, when appropriate, to execute all documents related thereto.

<u>AGENDA NOTE</u>: this application was executed by the President last week to meet the deadlines of the program.

- (20.3) adopt a resolution authorizing the Office of Juvenile Justice Services to submit an application in an amount up to \$300,000, and any revisions thereafter, to the Department of Justice, Bureau of Justice Assistance, for enhancement of the Calcasieu Juvenile Drug Court Treatment Program, and should residual funds become available, a grant adjustment can be filed to increase the grant award, and ratifying the signature of the President of the Police Jury on this application submittal, and further, authorizing the President of the Police Jury, and/or his designee, when appropriate, to execute all documents related thereto.
- (20.4) adopt a resolution authorizing the Office of Juvenile Justice Services to submit an application in an amount up to \$625,000, and any revisions thereafter, to the Substance Abuse and Mental Health Services Administration, Center for Substance Abuse Treatment, and the Office of Juvenile Justice and Delinquency Prevention to expand substance abuse treatment capacity of the Calcasieu Parish Juvenile Drug Court Treatment Program, and should residual funds become available, a grant adjustment can be filed to increase the grant award, and further, authorizing the President of the Police Jury, and/or his designee, when appropriate, to execute all documents related thereto.
- (20.5) adopt a resolution authorizing the Director of the Office of Juvenile Justice Services to negotiate and finalize terms and conditions of a contract for an amount up to \$1.5 million between the Police Jury and the Louisiana Department of Health and Hospitals, Office for Addictive Disorders, for the Strategic Prevention Framework implementation process for underage drinking and substance abuse prevention, and should residual funds become available, a grant adjustment can be filed to increase the grant award, and further, authorizing the President of the Police Jury, and/or his designee, when appropriate, to execute all documents related thereto.
- (20.6) adopt a resolution authorizing the Office of Juvenile Justice Services to submit an application in an amount up to \$500,000, and any revisions thereafter, to the Department of Justice, Bureau of Justice Assistance, for enhancement of the Calcasieu Juvenile Mental Health Court, and should residual funds become available, a grant adjustment can be filed to increase the grant award, and ratifying the signature of the President of the Police Jury on this application submittal, and further, authorizing the President of the Police Jury, and/or his designee, when appropriate, to execute all documents related thereto.
- (20.7) adopt a resolution authorizing the Office of Juvenile Justice Services to submit an application in an amount up to \$100,000, and any revisions thereafter, to the Louisiana Commission on Law Enforcement, Office of Violence Against Women Act (VAWA), for enhancement of the Girls Initiative on Responsibility and Life Skills program, and should

- residual funds become available, a grant adjustment can be filed to increase the grant award, and further, authorizing the President of the Police Jury, and/or his designee, when appropriate, to execute all documents related thereto.
- 21. Consideration of adopting a resolution approving a Managed Pharmacy Benefit Services Agreement between the Police Jury and the National Association of Counties (NACo) and CAREMARKPCS HEALTH, L.P. for the purpose of providing the citizens of Calcasieu Parish access to the NACo Prescription Drug Discount Card Program, and further, authorizing the President of the Police Jury, or his designee, when appropriate, to execute all documents related thereto.
- 22. Consideration of adopting a resolution approving the Fifteenth Extension of the Joint Services Agreement between the Police Jury, the Calcasieu Parish Sheriff's Office, the Calcasieu Parish District Attorney's Office, the Ward Three Marshal's Office, and the City of Lake Charles for the continuation of the TRIAD Program, and further, authorizing the President of the Police Jury, or his designee, when appropriate, to execute all documents related thereto.
  - <u>AGENDA NOTE</u>: as of this fifteenth extension, the Ward Three Marshal's Office and the City of Lake Charles have joined into this endeavor and entered into this agreement.
- 23. Consideration of adopting a resolution approving a Cooperative Endeavor Agreement between the Police Jury and Cameron Parish Mosquito Abatement District No. One regarding mutual aerial mosquito control services between parishes during times of need, and further, authorizing the President of the Police Jury, and/or his designee, when appropriate, to execute all documents related thereto.
- 24. Consideration of adopting a resolution approving the submission of LPDES permit applications to Louisiana Department of Environmental Quality for discharge permits for mechanical wastewater systems located at the following Parish Parks: Lorrain Park, White Oak Park, Holbrook Park, Intracoastal Park, and Calcasieu Point Landing, and further, authorizing the President of the Police Jury, and/or his designee, when appropriate, to execute all documents related thereto.
- 25.
