AGENDA NOTE: on Thursday, June 4, 2009, a motion was made to suspend and/or delay the demolition of eleven mobile homes and associated junk and debris at 1331 Alton Pierce Road in Ward Six (said property having been condemned by virtue of Ordinance No. 5648 adopted by the Police Jury on April 23, 2009) for two weeks to allow Mrs. Bobbie Pierce, owner of the property, to make arrangements for demolition which would include hiring a contractor, obtaining proper permits, and in general, proceeding with the necessary steps to demolish and remove the structures, and further, that if Mrs. Pierce does not make such arrangements within two weeks, the Parish would then proceed with enforcement of Ordinance No. 5648 by awarding the contract for demolition to the low bidder, C. J. LeJeune of LeJeune Tractor Service, following which a lien would be placed on the property for the cost of demolition.

Consideration of adopting a resolution authorizing (1) the solicitation of proposals from qualified professional firms to provide program management services in the utilization of Gustav/Ike CDBG-Disaster Recovery Funding, and (2) appointment of a Selection Review Committee to review and rank the proposals, in accordance with Police Jury's CDBG Disaster Recovery Procurement Policy and the CDBG Disaster Recovery Program, and further, authorizing the President of the Police Jury, or his designee, when appropriate, to execute all documents related thereto.

## Item No. Three:

Consideration of ratifying the execution by the President of the Police Jury of a Local Government Proclamation of State of Emergency signed on Tuesday, June 16, 2009, proclaiming a State of Emergency to exist in Calcasieu Parish due to the fire station at Chennault International Airport being destroyed by fire on June 16, 2009.
