  - Mr. Smart announced that the final phase of construction of Red Davis-McCollister Road had been completed, and said road had been opened for traffic on this date, pointing out that South Park Road would serve as an alternate route when reconstruction of Common Street took place.
  - (11.2) Recommended that the <u>Code of Ordinances of Calcasieu Parish</u>, <u>Louisiana</u>, be amended to provide for (1) establishing a speed limit within all parish parks, (2) establishing drug-free zones at Intracoastal Park and Calcasieu Point Landing, and (3) updating and/or clarifying other sections regarding parks and recreation. Consideration of adopting a resolution indicating objection/no objection to the following proposed projects in Calcasieu Parish, Louisiana, provided said work meets with the rules and regulations of the Corps of Engineers, Best Management Practices during the course of construction set forth by the Environmental Protection Agency guidelines, and approvals are received from all other appropriate state and federal agencies, and further, that any required permits are obtained from the Division of Planning and Development:
  - (12.1) Proposal of Mr. Scott Worley and Mr. Robert Guillory to install and maintain 370 linear feet of bulkhead and 150 linear feet of dock with terminal pavilion. Approximately 3,800 cubic yards of hauled-in earthen material will be used as backfill. The described work is to be conducted within an area 330 feet long located approximately parallel to the mean low water shoreline, the outer edge to extend 179 feet lakeward therefrom. Said project is located at 3305 Henderson Bayou Road on Prien Lake in Lake Charles. The Planning Staff recommends that the Police Jury indicate no objection to this project application.
  - (12.2) Proposal of Texas Petrochemicals to dredge to remove approximately 8,700 cubic yards of waterbottom sediment to provide adequate water depth for marine vessel access to an existing barge docking facility. Said project is located in Bayou D'Inde at a point about 4.5 miles above its confluence with the Calcasieu Ship Channel in Sulphur. The Planning Staff recommends that the Police Jury indicate no objection to this project application.
  - <u>AGENDA NOTE</u>: any resolution of no objection to any project, if adopted, will stipulate that such "no objection" is based solely on evaluation by the Parish Planning and Development Staff relative to the project's compliance with current parish ordinances and provisions, and that no environmental assessment was made, and further, requesting the agencies and/or individuals with environmental expertise to make an evaluation and forward their findings to the U. S. Corps of Engineers.
- 13. Consideration of adopting a resolution approving the Coastal Impact Assistance Program (CIAP) Revised Project List which will be submitted to the Department of Natural Resources for the State's Coastal Impact Assistance Program Plan, and should additional funds become available, the list can be amended to add projects, and further, authorizing the President of the Police Jury, or his designee, when appropriate, to execute all documents related thereto. (see attached)
- 14. Consideration of adopting a resolution approving the submittal of an application by the Division of Planning and Development to the Governor's Office of Homeland Security and Emergency Preparedness (GOHSEP) for the Hazard Mitigation Grant Program (HMGP) application for Hurricane Ike funds (\$6.4 million allocation includes Parish and Cities), and should additional funds become available, the application can be amended to increase this amount, and further, authorizing the President of the Police Jury, or his designee, when appropriate, to execute all documents related thereto.
  - AGENDA NOTE: a Letter of Interest was submitted by the deadline of June 30, 2009.
- 15. Consideration of adopting a resolution for the transfer of funding received by the Louisiana Recovery Authority (LRA) to three homeowners whose property was acquired by the Parish, as a result of a resolution adopted by the Police Jury on September 20, 2007, wherein a 75% match was approved to said homeowners, with said transfer amounting to the remaining 25% match, all in accordance with the Hazard Mitigation Grant Program (HMGP).
  - <u>AGENDA NOTE</u>: the homes in question are located at 2442 Mark Lane in Ward One, and 1110 Gulf Lane and 804 Neil Road in Ward Four.
- 16. Consideration of adopting a resolution approving revisions to an Agreement between the Police Jury and Oliver Schulz & Associates for administrative services on the LCDBG Mossville Sewer Line project, and further, authorizing the President of the Police Jury, or his designee, when appropriate, to execute all documents related thereto.

- 19. - 21.
