The Police Jury shall sit as a Board of Review to hear any protests on current tax assessments, and take appropriate action thereon.

<u>AGENDA NOTE</u>: the review period began August 17, 2009, and ended on August 31, 2009, in the Calcasieu Parish Tax Assessor's Office.

6. Consideration of adopting an ordinance amending the <u>Code of Ordinances of Calcasieu Parish</u>, <u>Louisiana</u>, providing for a civil penalty to be imposed against motorists who are determined by the Calcasieu Parish Sheriff's Office to be in violation of illegally passing a stopped school bus following a review of the video by the Sheriff's Department, with the effective date of said ordinance to be when all municipalities have either adopted a similar ordinance or entered into a joint services agreement to participate in enforcement of the program.
